**Post Election Summary Report, After-Action Report:
April 26, 2011 Special Election**

Introduction

On April 26, 2011, the District of Columbia Board of Elections and Ethics conducted a special election for the vacant position of At-Large Member of the Council of the District of Columbia created by the election of Kwame Brown as Chairman of the Council in November 2010. Additionally, on that same date and as permitted by law, the Board conducted elections to fill vacancies from Ward 4 and Ward 8 on the State Board of Education.

Special elections traditionally require fewer resources due to lower voter turnout; however, many election administration tasks must be performed regardless of voter participation. The Board sought to meet dramatically reduced funding by limiting the use of temporary staff and reducing the use of many other resources. The Board faced several challenges managing this election including severe budget cuts, and overcoming difficulties related to implementing reforms in the 2010 election cycle including late voting machine openings and delayed results. While there are always challenges – including difficulties opening and shutting down the equipment in a few precincts – the number of issues was greatly reduced and the Board exceeded its own expectations in completing the tabulation and release of election results. These achievements were a result of careful planning, a nimble and dedicated workforce, and significant steps taken to reduce costs and improve efficiency.

The District of Columbia has some of the most progressive election laws in the nation, and the professional staff of the Board is committed to making sure that every voter has the opportunity to cast a ballot and have it counted fairly and accurately. Voters in the District have many opportunities to cast a ballot, including early voting and the ability to vote by mail regardless of the reason. District voters can also register at the polls on Election Day, which in the special election resulted in nearly 96% of special ballots ultimately being counted.

At the same time, the Board recognizes that it has a dual obligation to the voters, both as customers and as taxpayers. Due to the fiscal constraints facing the District, the Board cut costs dramatically for the special election by taking such steps as eliminating early voting centers and electronic poll books, hiring fewer pollworkers and temporary employees, and relying on existing inventory rather than printing and purchasing new signs and equipment. Many of these savings cannot be repeated in a high-turnout presidential election year, and some – such as reducing the inventory of supplies and equipment – shifted costs forward into the next fiscal year. The Board demonstrated in the special

election that there are ways it can trim costs, and its staff intends to build on those successes moving forward as well as take additional steps to improve efficiency.

This After-Action Report discusses the successes and lessons learned from the April 26 special election, including the steps taken to improve efficiency and strengthen operations, as well as the implications of these lessons for future elections in the District of Columbia. To allow for comparison with other elections held in the District, this report provides information as described under 3 DCMR §817.1.

A. The total number of ballots cast and counted, with subtotals for each type of ballot:

Ballots were cast by **47,227** voters, or **10.3%** of all registered voters in the District. While this is a small percentage of voters, it is a typical turnout for a special election and more than 50% higher than turnout for the last citywide special election in 1997, when voters elected an At-Large Member of the Council with 25,701 total ballots cast or 7.5% turnout.

Most voters cast ballots in their polling place on Election Day. Due to budget constraints, the Board did not open early voting centers. Voters were, however, able to cast an absentee ballot by mail or in person at the Board’s office during the two weeks prior to the election. Of the **3,969** absentee ballots received, **2,118** – or more than **53%** - were submitted early or over the counter at the Board’s office, rather than by mail.

The Board extended its early voting absentee hours to include Palm and Easter Sunday to provide greater opportunities for persons wishing to cast a ballot prior to Election Day and to accommodate Jewish voters observing Passover on Election Day.

B. The total number of spoiled and special ballots not counted:

Voters who made errors before casting their paper ballots were allowed to receive up to two replacement ballots. Only **307** of the total number of ballots used in the election were reported spoiled.

In addition, the Board rejected only **67** of the total **1738** special ballots cast in the election. Of those rejected, **63** were cast by voters filing Same Day Registrations who either failed to provide the required identification or cast their ballot in the incorrect precinct on Election Day.

The total number of spoiled and special ballots not counted is as follows:

C. The total number of persons registered to vote more than thirty (30) days preceding the election, broken down by party, ward, and precinct:

Voter registration by mail closes on the thirtieth (30th) day before each election. The total number of voters registered to vote more than 30 days preceding the election, or prior to close of registration by mail, is broken down by ward and party in the table

D. The number of persons who registered to vote between thirty (30) days preceding the election and the date of the election:

After the thirtieth (30th) day and until in-person absentee voting begins, voters must either register to vote in person at the Board’s office or at one of the designated NVRA agencies.

The total number of persons who appeared in person either at the Board’s office or a NVRA agency to register during the thirty (30) days preceding the election and the date of the Special Election is as follows:

E. The number of persons who registered to vote at an early voting center:

A total of **26** same day registrations were filed at the early voting in person absentee center.

F. The number of persons who registered to vote on Election Day:

Voters in the District are allowed to register and vote on Election Day. Voters casting a same day registration (SDR) must provide identification prior to voting.

During this election, for the first time, voters registering on Election Day who presented government-issued photo identification were allowed to cast a regular ballot. Poll workers found the process for determining whether to issue a special ballot or a regular ballot to same day registrants confusing. There were a few same-day registrants who were provided regular ballots; however it is impossible to determine the exact numbers of since their votes are included in the general precinct results. The confusion created by having two classes of acceptable identification may need to be addressed by the Board and Council for future elections.

The total number of Same Day Registrations filed on Election Day was **269**. The chart below shows a breakdown of the total of registrations completed on Election Day by ward and party.

G. The number of polling place officials at each precinct, broken down by position title:

To cut costs, one of the first places that the Board looked was polling place staffing. After evaluating previous staffing levels and expected turnout, the Board set a target for the number of workers and the roles required in each polling place. These targets were based on past turnout as well as factors such as the layout of the polling place and the typical number of curbside voters in the precinct. Overall, staffing was cut by more than a third. While these staffing levels proved to be sufficient, they reduced the margin for error,

made it even more important to recruit only the best and most reliable workers, and required pollworkers to accomplish the same tasks at the beginning and end of the day without the usual number of workers to assist.

The Board employed a total of **830** workers, including a few workers who worked part-time on Election Day. A breakdown of the special election staffing at each polling place by position title is calculated below:

H. Copies of any unofficial summary reports generated by the Board on election night:

A copy of the unofficial summary report generated by ward and precinct on election night is attached to this report.

I. A summary of issues identified in Precinct Captain or Area Representative reports:

There was only one reported instance of a polling place that did not open its doors on time at 7:00 a.m. because the precinct captain waited to open the doors while she searched for paperwork. Eleven precincts were still following opening procedures on their scanners when they opened the doors, but were scanning ballots within the first 15 minutes. Only five precincts were still having problems 15 minutes after the polls opened, and only two had voters casting ballots in an auxiliary paper bin after the first half hour. In most cases, this was because pollworkers stopped the equipment and called the help desk when an unfamiliar error message appeared which indicated that the machine was running on a low battery because it had not been plugged in overnight.

Although the Board improved its on-time performance for paper ballot scanners, pollworkers continue to struggle with the procedures for starting the touch screen voting machines. This is a multi-step and time-consuming process that requires pollworkers to disconnect the voter-verifiable paper audit trail printer, connect a separate printer, print a report, and then connect the first printer again. It is very important for pollworkers to devote their attention to the steps, because mistakes can require a time-consuming call to the help desk and prevent ballots from being cast on the touch screen. The Board's analysis of opening times printed from the machines revealed that 16 precincts did not finish this process within the first fifteen minutes of paper ballots voting - significantly more than in the November election (nine precincts).

This was a surprise to the Board's technical staff, which did not see a corresponding increase in problems reported during the day and highlights the value of a thorough post-election analysis to identify areas for improvement. Overall, the help desk only received slightly more than 200 calls (down from more than 900 on the day of the primary election and 500 in November). The percentage of calls that were about the voting equipment also dropped, from 45 percent to 33 percent.

In addition, there were two precincts that received supplies for the wrong location and pollworkers did not have the correct list of registered voters for their precinct when they opened their doors in the morning. Pollworkers offered provisional ballots to the affected voters until the correct list of voters arrived and these ballots were all counted. The correct supplies were provided by 10 A.M.

The Board refined its incident response plans and improved its training and recruitment for field support personnel. In addition, the Board integrated its public outreach – including aggressive use of social media – with its support dispatch team, resulting in a

rapid and transparent response to issues raised by voters, campaigns and the media as well as those called in by pollworkers.

The table below indicates the major categories of issues called in to the help desk provided for pollworkers.

J. Performance measurement data of polling place officials:

In order to meet the budget, a bonus was not offered to Precinct Captains for the Special Election; however, the performance expectations remained the same and the Board evaluated precinct performance on these expectations including; examining the opening times for voting equipment and proper packing of bags for return. We modified a few of our forms to assure that they would be completed correctly and found that, despite removing calculations from our Ballot Accounting Form, pollworkers had difficulties in correctly capturing the accurate number of ballots used during the day.

Additionally, as a result of only providing training on opening and closing the voting equipment to the Precinct Captain, there was a slight increase in late machine openings – the polling place opened on time. Our assumption is that when trouble arose, there was no one else in the precinct to assist, so the Captains waited for assistance which may have caused delays in opening the equipment. Attached to this report are performance measurement data for each Precinct Captain.

K. A description of any irregularities experienced on Election Day; and

Aside from issues discussed in section I above, there were no notable irregularities on Election Day. The Board did institute a more comprehensive process audit following the election in which staff reconciled all ballot accounting materials, vote tabulation, machine reported vote totals and tabulation software vote totals. In the course of this audit it was discovered that audit logs on two voting machines were incomplete due to

improper machine closing. The Board also determined that two precincts' special ballots were not correctly returned to the board in the ballot bag but were shipped with other election materials to the Board's warehouse. The Board has instituted a policy to conduct this more through audit of all ballot materials prior to the conducting of the post election audit required by District law.

L. Any other relevant information

Pollworker payment improvements

The Board decided not to subject payroll to the materials lockdown as was done during the General Election and was able to begin processing payroll 3 days after the election. While some formatting of the information sent to the finance department created a slight delay during the General Election, the issue was resolved prior to the Special Election and the potential delay was prevented. With almost half the number of pollworkers to process and fewer unanticipated workers working the election, the Board was better able to provide fast, clean data to the finance department to greatly improve turnaround time. The payroll checks were mailed to poll workers 3 weeks after the election – one week prior to the expected 4-6 week deadline – and nearly a month faster than the 2010 General Election.

Polling Place Accessibility issues

The District of Columbia Board of Elections and Ethics has a mandate to take reasonable steps to facilitate voting by the blind, physically handicapped, and developmentally disabled persons. The Board strives to work with University Legal Services (ULS) to achieve a consensus with respect to identifying and correcting accessibility issues in polling places. The Board also works in conjunction with the Office of Public Education Facilities Management (OPEFM); the Department of Real Estate Services (DRES); the Office on Disability Rights (ODR); and the Department of Parks and Recreation (DPR) to identify and make structural improvements to public facilities used as polling places. The District government expended in excess of a million dollars during the previous election cycle on facility upgrades mainly in the form of ADA Accessible Guidelines (ADAAG) certified ramps for entry; ADAAG door handles; and parking signage.

In its recent review of polling places used in the Special Election, ULS claimed that five precincts surveyed were structurally inaccessible; however, the Board disputes this. An illustrative example is the analysis of precinct 46 E.L. Haynes public Charter School which complains that a door to the facility is not accessible, however that door was not used by voters in the April 2011 election. ULS also cited polling places where voting machines were placed in a manner that did not provide the sufficient turning radius. The Board has implemented an accessibility component in our poll worker training that should address this concern; moreover, we are mindful of this issue for future elections and are in active negotiations with ODR to implement accessibility sensitivity training for our poll workers. All precincts have the requisite equipment such as magnifying glasses and audio headsets packed in the equipment sent to each precinct – we will stress prominent placement and signage to alert the public to their availability. All precincts have designated parking cordoned off in front and a doorbell to notify pollworkers of the need to provide service to a disabled voter.

It is important to note that neither the Board nor the Office on Disability Rights received constituent complaints regarding voting accessibility during the Special Election. As we have noted in previous editions of the ULS accessibility report, we dispute many of its findings and would appreciate an opportunity to accompany ULS in its surveys all parties have same assumptions regarding what areas need to be addressed at each precinct.

The Board has worked with ULS and is receptive to suggestions of alternatives to the relatively few structurally inaccessible sites. Some alternatives raised by ULS were not receptive to hosting a polling place. Finding an alternative location as ULS has suggested is only part of the task of reassignment – the Board must also come to an agreement with the property owner. We are in the process of preparing for the Primary Election, and now is the perfect opportunity to work with the new staff at ULS to address

these concerns. We appreciate all their efforts and look forward to working with them during this election cycle.
