

NOVEMBER 8, 2022 GENERAL ELECTION AFTER-ACTION REPORT

### I. INTRODUCTION

Under D.C. Official Code §1-1001.05(K) and 3 DCMR § 817, within 90 days following a general election, the District of Columbia Board of Elections ("the Board") must publish on its website an after-action report containing certain data and information concerning the election. Accordingly, DCOBE presents this after-action report ("the Report") on the November 8, 2022 General Election ("the Election").

# II. D.C. OFFICIAL CODE §1-1001.05(K)/ 3 DCMR § 817 DATA

# A. Ballot Data

- 1. Total number of votes cast and counted, broken down by type of ballot, including the number of spoiled and special ballots that were not counted:
  - a. Total Number of Ballots Cast: 205,774
  - b. Total Number of Ballots Cast during Early Voting: 15,438
  - c. Total Number of Ballots Cast on Election Day: 59,538
  - d. Total Number of Mail Ballots Cast: 130,798

DCBOE sent 506,456 mail ballots to domestic voters, and 730 mail ballots to voters covered by the Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA).

Of the 506,456 domestic mail ballots transmitted:

- 205,774 were returned and counted
- 132,829 were returned and rejected
- 87,921 were returned as undeliverable
- 2,499 were spoiled and voided
- 291,091 were neither returned by the voter nor returned as undeliverable

Of the 730 UOCAVA ballots transmitted:

- 469 were returned and counted
- 5 were returned and rejected
- 4 were returned as undeliverable
- 0 were neither returned by the voter nor returned as undeliverable

e. Total Number of Special/Provisional Ballots Cast: 430

Of the 430 Special/Provisional Ballots cast:

#### **B.** Registration Activity Data

- 1. The Number of Persons Registered
  - a. More than 21 days preceding the election, broken down by ward, party and precinct: There were 504,815 registered voters as of October 18, 2022.
  - **b.** Between 21 days preceding the election and Election Day: There were 1767 new registrations between October 18, 2022 and November 8, 2022.
  - c. Same Day Registration: There were a total of 4,758 same-day registrations.
