

**MINUTES OF THE BOARD OF ELECTIONS REGULAR MEETING  
July 18, 2023**

The District of Columbia Board of Elections (“the Board” or “BOE”) held its Regular Monthly Meeting on Tuesday, July 18, 2023, via Zoom and in the Board’s Hearing Room, located at 1015 Half Street, SE, Washington, D.C. 20003, Suite 750. Board Chairman Gary Thompson and Board Members Karyn Greenfield and J.C. Boggs were present. BOE Executive Director Monica Holman Evans (“Director Evans”), BOE General Counsel Terri Stroud, Office of Campaign Finance (“OCF”) Director Cecily Collier-Montgomery (“Director Collier-Montgomery”), and OCF General Counsel William SanFord were also present.

**CALL TO ORDER (10:38 a.m.)**

**ASCERTAINMENT OF QUORUM**

- Board Chair Thompson and Board Members Greenfield and Boggs constituted a quorum.

**ADOPTION OF AGENDA/APPROVAL OF MINUTES**

- **BOARD ACTION:** The Board unanimously adopted the agenda and minutes from the last meeting held on June 20, 2023.

**DCBOE EXECUTIVE DIRECTOR’S JUNE 2023 REPORT (EXECUTIVE DIRECTOR EVANS)**

- **Hearings**
  - On June 7, Director Evans appeared before The Joint House Administration Committee and Committee on Oversight and Accountability to discuss election integrity in the District.
  - On June 26, Director Evans testified at a roundtable before the D.C. Council Committee on Executive Administration and Labor (“CEAL”), where she discussed preparations for the 2024 election cycle and the implementation of newly-passed election-related legislation.
- **Precinct Mapping**
  - The Board is working with Gottlieb Simon to review current precinct boundaries to divide the District into appropriate voting precincts based on election wards.
  - The Board is working with Electionware election software to create additional Advisory Neighborhood Commission (“ANC”) Single Member Districts (“SMDs”), which involves several simulations before mapping finalization.
- **ANC Vacancies**
  - There are 13 ANC vacancies for the 2023/2025 term, all of which are in different

stages of being filled. After candidate filing requirements are met, an open vote of registered voters within the SMD will be held during regularly scheduled ANC meetings.

- At the end of the month, vacancies are expected to increase based on current resignation notifications.
- **2023 Next Steps/Off-Election Year Planning**
  - Draft calendars for the 2024 Primary and General elections are now posted on the Board's website.
  - 2024 election cycle worker applications are currently being processed, and worker assignment and training forms are being updated.
  - The Board is updating special ballot envelopes and Poll Pad prompt screens to facilitate non-citizen voting consistent with new legislation.
  - The Elections Modernization Amendment Act ("EMA") and Local Resident Voting Rights Amendment Act ("LRVR") requirements are being reviewed to ensure the Board's compliance.
  - The Board is in talks with its voter registration database vendor, VR Systems, regarding the data visualization interface that the EMA requires for the Board's website and the creation of a database solution to house non-citizens who register to vote in local elections.
  - The Board will require additional equipment to assist with mail ballot processing. Funding received in the FY 2024 budget will go towards the purchase of a mail ballot processing machine.
  - The Board is crafting brochures that will be used for outreach to non-citizens in the District.
  - The Board is updating the Election Worker Training Manual, developing the 2024 Voter Education and Outreach Plan, and assessing our Vote Center and Mail Ballot Drop Box locations plan.
  - Dropbox locations will be posted late August/early September for public comment.
  - Although the Board is an ERIC member, it has also joined a cross-state data working group to explore ways to share voter history and address cross-state voter fraud.
  - The Board was informed by the D.C. Department of Motor Vehicles ("DMV") that they are not utilizing the state-to-state data sharing program that reports cancelled licenses.
  - The Board is engaged in conversations with Maryland, Virginia, and North Carolina to discuss the best ways to share data and update information outside of ERIC.
  - The Board has received recent voting history from ERIC, along with a list of voters who have moved within D.C. and a list of voters identified as deceased.
- **Voter Education and Outreach (VEOD)**
  - During June, six outreach events were conducted, including voter registration drives at Pennsylvania Avenue Baptist Church and the Mayor's 12<sup>th</sup> Annual Senior

Symposium.

- The VEOD is preparing a voter education/outreach strategy to be used in the implementation of the LRVR.
- The Board has received funding to hire a multilingual outreach specialist.
- **Voter Registration Rolls**
  - In June, the Voter Services Division registered 2,163 new voters and processed 5,145 registration changes.
  - In total, 7,308 voter registration cards have been prepared for mailing.
  - 39 registered voters moved out of D.C.
  - 617 voters registered moved into D.C.
  - 321 voters canceled their D.C. registrations and registered with other jurisdictions.
- **Online Voter Registration**
  - 36,125 applications have been processed to date.

## **OCF JUNE 2023 REPORT (DIRECTOR COLLIER-MONTGOMERY)**

- On June 26, Director Collier-Montgomery gave testimony on the Fair Elections Program (“FEP”) at a roundtable regarding elections before the CEAL.
- **Fair Elections Program (FEP) Division Report**
  - A total sum of \$13,557,106.70 has been authorized for disbursement from the FEP Fund in base amounts and matching payments to the 42 candidates certified in the FEP to participate in the June 21, 2022 Primary Election and in the November 8, 2022 General Election.
  - All candidate names are listed on the OCF website.
  - **Desk Reviews and Other Activities**
    - The FEP Division conducted 29 desk reviews of initial and amended Reports of Receipts and Expenditures (“R & E Reports”).
    - Four request for additional information (“RFAI”) letters were sent.
  - **Remitted Funds**
    - As of June 2023, the total sum of \$686,433.82 has been remitted back to the FEP fund from candidates who were certified to participate in the 2022 election cycle.
  - **Ongoing 2020 Post-Election Full Field Audits**
    - There are currently 15 post-election audits.
    - The details of those audits are listed on the OCF website.
    - The FEP has issued a total of 19 final audit reports; the details of those audits are listed on the OCF website.
  - **Ongoing 2022 Post-Election Full Field Audits**
    - The FEP issued 42 Post-Election audit letters to candidates who were certified to participate in the 2022 Election Cycle.
    - The FEP issued one preliminary audit findings report issued on June 13, 2023, in the matter of Sriqui for Ward 3 Schools DC SBOE; the details of the audit findings report are listed on the OCF website.

**OCF JUNE 2023 GENERAL COUNSEL REPORT (GENERAL COUNSEL WILLIAM SANFORD)**

- **Intake/Output Report**
  - OGC received two referrals.
  - Eight informal hearings were held and eight orders were issued:

    - Six orders were issued in which a total of \$9,850 in fines was imposed.

**DCBOE GENERAL COUNSEL’S JUNE 2023 REPORT (GENERAL COUNSEL STROUD)**

- **Litigation Status**
  - **Public Interest Legal Foundation (“PILF”) v. Monica Evans (U.S. District Court for the District of Columbia)**
    - The suit alleges that the Board is out of compliance with the NVRA’s public records provision.
    - The motion to dismiss filed by the Office of the Attorney General (“OAG”) on behalf of the Board was denied; the next step will be the issuance of a briefing schedule.
  - **D.C. Board of Election v. Lamont Harrell**
    - This matter is a petition for enforcement of a fine imposed by OCF for failure to file a campaign finance report.
    - The Court granted the Board’s petition for enforcement, and a judgment was entered.
  - **Stacia Hall, et al., v. D.C. Board of Elections (U.S. District Court for the District of Columbia)**
    - This case involves a challenge to the LRVR on the grounds that the U.S. Constitution precludes non-citizens from voting.
    - The OAG filed a motion to dismiss on July 14, and any reply is due July 28.
- **Proper Subject Matter Determination Hearing for Proposed Initiative Measure, “Make All Votes Count Act of 2024”**
  - On June 16, Lisa Rice filed a proposed initiative measure that seeks to implement ranked-choice voting and open primary elections to voters whose voter registrations are not affiliated with any party.
  - The submission triggered a statutory requirement that the Board determine whether the proposed measure meets proper subject matter requirements, such as the requirement that initiatives cannot interfere with the Council’s discretion over spending, conflict with Home Rule or the Constitution, or authorize conduct that would constitute discrimination in violation of the law.

- As required by law, the OAG and the General Counsel to the Council have submitted advisory opinions as to whether the pending measure presents a proper subject.
- The Board opened the floor to comments from the public as to whether the measure satisfies proper subject matter requirements.
