DCBOE Publishes Results of the Manual Audit of the 2022 General Election

WASHINGTON, D.C. – The District of Columbia Board of Elections (DCBOE) has completed the public manual audit of the November 2022 General Election, which took place on Monday, November 21, 2022 and Tuesday, November 22, 2022.

As required by District of Columbia law, DCBOE conducted a hand count of all votes cast in one randomly selected precinct per ward in one citywide contest (United States Representative) and two ward-wide contests (Ward 6 Member of the State Board of Education and Ward 5 Member of the Council) for the audit.

Typically, differences between the hand count and the machine count are the result of additional or incomplete marks made by a voter on the ballot or the result of counting errors made by members of the audit team.

The margins of error do not exceed the statutory allowance of 0.25%, and therefore, no further action is required by the Board. Official results of the November 2022 General Election will be certified during the Board’s regular public meeting on Wednesday, November 30, 2022 at 10:00 am.
