## **NEW Satellite Early Voting Centers Opening on October 26**

**WASHINGTON, D.C.** - The District of Columbia Board of Elections (DCBOE) would like to notify residents that five (5) new Early Voting Centers will be open in advance of the November 6 General Election.

As usual, beginning on October 22, and through November 2, voters can vote early at One Judiciary Square (OJS). This is the **only** Early Voting Center that will have paper ballots. Residents from **any ward** may vote at OJS during Early Voting.

Beginning on October 26, Satellite Early Voting Centers will open throughout the District. Below is the complete list of Early Voting Centers and again, voters may vote at **any Early Voting Center regardless of their address**. Please note that all Satellite Early Voting Centers will have **touchscreen ballots only**.

Same day registration is available at all Early Voting Centers with proper proof of address.
