DCBOE Has Completed the Recount in Ward 5 Member of the Council Race

WASHINGTON, D.C. - On July 25, 2018, the District of Columbia Board of Elections (DCBOE) began a recount of the votes cast in the Ward 5 Member of the Council Democratic Primary Election contest, which was held on June 19, 2018. The petition for recount was submitted by candidate Gayle Hall Carley. The recount began at 10:00 am on July 25, 2018 and concluded for the day at close of business. The recount was scheduled to start again on Thursday, July 26, 2018; however, Ms. Carley submitted a request to terminate the recount effective July 26, 2018.

On July 25, DCBOE recounted all ballots cast in precincts 19, 66, 67, and 74. The request to terminate the recount was submitted to DCBOE after these four precincts were completed. Results of the recounted precincts were the same as the certified election results with the exception of Precinct 66. In that precinct, the certified election results showed that candidate Kenyan McDuffie received 961 votes, and the recount results showed that he received 960 votes. This one-vote difference had no impact on the outcome of that contest. Accordingly, DCBOE will not make a new certification of the election results.
