Official Code §§ 1-204.111 to 1-204.115).

Failing to address basic matters; streets, alleys littered w/trash, dog feces; most 5D05 residents don't know her 2. Holding secret meetings; most in 5D05 have no idea when/where meetings are 3. Scheming; approved fraudulent ANC grants to friends, despite warning from D.C. Auditor, Office of Advisory Neighborhood Commissions. Voted to give Virginia organization \$20,000.00 grant at 5-11-21, ANC meeting; matter referred to Office of Inspector General, Office of Attorney General (OAG) 4. Using 5D05 boundaries to set up a shadowy political civic association to push Carver Terrace Apartment residents out; they can't join 5. Used 5D05 position to file false complaint with OAG; filed false police and Court cases 6.
