18	When we certified results on December 2nd, we did
19	not have the most accurate write-in count. And
20	so, we wanted to ensure that we had those numbers
21	done correctly before certifying that contest,
22	and so I present to you ANC 6B04 write-in contest

1 winner, Brian Gorman, for certification. 2 MR. THOMPSON: All right. Well, thank 3 you for that. I -- therefore, I'll move that we 4 certify that final ANC result. 5 MS. GREENFIELD: I second it. MR. THOMPSON: All in favor? 6 7 Obviously both of us, so --8 MS. GREENFIELD: Aye. 9 MR. THOMPSON: With that we certify 10 that ANC race. 11 MS. STROUD: Yes, thank you. And with 12 that, I just want to inform everyone that, 13 because the certification has taking place today, 14 there is a seven-day period during which any --15 during which candidates could seek a recount or 16 any voter may request judicial review of the 17 election. So, that would expire on December 18 20th, 2024. 19 Thank you. And Mr. Chair, MS. EVANS: 20 the only other thing I would just add for the 21 record, and we did issue a press release, but 22 just so that you know, we did have one recount in

ANC SMD 3/4G05, Precinct 50, and the results did 2 not change as a result of that recount. There was a two vote difference and Karrenthya Simmons 3 4 remains the winner of that contest. So, that 5 certify contest remains as it was certified on December 2nd, so just FYI. 6

7 Yeah, thanks for that. MR. THOMPSON: 8 I tuned in a little bit, but there isn't much to 9 watch from Zoom. But I do want to thank Kevin 10 Newsom and Millicent Wright and, you know, 11 everybody who sat down to do that. It's not an 12 easy chore, it took a couple hours, so I didn't 13 pay attention to all of it.

14 But I was also pleased to see that, 15 you know, the count was spot on. You know, so 16 it's a measure of comfort that, you know, we --17 our original count of the votes was spot on 18 accurate. So, thank you.

19 Yes, thank you. MS. EVANS: 20 All right, I quess MR. THOMPSON: 21 that's all we have. And this might be our very 22 last board meeting of 2024.
