## ADA Compliance Election Worker Application

### Eligibility Criteria:

To serve as an ADA Compliance Election Worker, you must meet the following criteria:

- Be at least 18 years of age
- Be authorized to work in the United States
- Have access to reliable transportation

### Requirements:

- Complete the training class on 10/22/2024; Be available on Election Day November 5, 2024 from 6:00am – 8:00 pm

### Selection Process:

- Submission of an application does not guarantee that you will be selected
- Not all volunteers will be assigned to their preferred Vote Centers
- \$300 Stipend (Training Class + Election Day)

# ADA COMPLIANCE ELECTION WORKER POSITION (November 5, 2024)

The District of Columbia Board of Elections (DCBOE) is committed to ensuring that all District of Columbia residents have equal access to the voting process. Accordingly, we are inviting you to join our Americans with Disabilities Act (ADA) compliance team and work with our ADA Coordinator to make all vote centers operationally accessible on Election Day.

## ➤ JOB RESPONSIBILITIES

- Evaluate assigned vote centers on Election Day using the DOJ approved ADA compliance checklist and make changes where necessary. Make sure that all accessible entrances are properly identified.
- Keep ramps and wheelchair accessible doors unlocked and barrier-free. Also, make sure the accessible routes are free of obstructions and protrusions.
- Make sure the appropriate signs are posted to identify accessible parking, accessible drop-off zones etc.
- Work with Site Coordinators and the ADA Coordinator to correct any instances of noncompliance.

## ➤ JOB REQUIREMENTS

- A high school diploma or applicable work experience considered.
- Prior experience working with senior citizens and/or individuals with disabilities is preferred.
- Experience working during an election is preferred.
- Travel is required; volunteers must have access to reliable transportation to travel between 3-5 precincts.
- Must have access to a working cell phone to communicate with supervisor and team members.
- Must be at least 18 years of age and a United States Citizen.

- **November 5, 2024 (6:00am-8:00pm)**
- **Stipend for volunteers: \$300 total**
- You **DO NOT** have to be a District of Columbia resident to apply.
- **BILINGUAL VOLUNTEERS** are highly encouraged to apply. We welcome ALL interested volunteers.
