# OCF MAY 2020 REPORT (DIRECTOR COLLIER-MONTGOMERY)

- Search feature made available at the OCF Website providing public access to the
  Matching and Base Amount payments authorized for disbursement by OCF in the Fair
  Elections Program (FEP) by candidate, and overall FEP disbursement totals, as well as
  registration information for each FEP candidate, including date of registration;
  certification status; and history of financial reports filed, with link to report image, and
  public funds payouts.
- OCF continues to operate under modified status; services are being provided remotely by email and telephone 202-671-0547.
  - All candidate and committee reports will continue to be received online at the OCF website on the required deadline.
  - o Candidates can contact OCF for instructions on the registration process.
- Fair Elections Program Division (FEP)
  - o Forty-four (44) committees registered in the FEP, and thirty-eight (38) of the committees are active.
  - On May 26 and June 1, seven (7) committees were notified of their failure to meet the qualifications for certification into the FEP during the qualifying periods, which ended on March 4 for the June 2 Primary Election and on March 18 for the June 16 Ward 2 Special Election

- BOARD ACTION: The Board unanimously approved motion to certify the June 2 Primary Election results
- Other Matters
  - o Approximately 92,000 ballot requests were fulfilled for the June primary
  - o 20 vote centers utilized for June primary
  - o 735 radio ads played across 17 stations
  - o 5.4 million digital ads were served to DC residents
  - o 21 print ads across 7 outlets
  - o 27 community meetings held
  - Several commercial ads played on television
  - o Confusion was acknowledged regarding the Vote for DC app
    - BOE is working to terminate relationship with the app vendor
    - Ballot tracking was not functioning properly
    - The application absentee request malfunctioning caused issues in processing
  - o BOE is currently working to improve processes for upcoming elections
  - Board member Gill noted that waiting 3-4 hours in line was unacceptable, and that the Board will work to improve on the aspects of the absentee process that went awry during the Primary Election.

## **BOE OGC MAY 2020 REPORT (GENERAL COUNSEL STROUD)**

## Rulemaking

- Emergency and Proposed Rulemaking Amend Title 3 DCMR Chapter 7
   (Establish the deadline for the receipt of absentee ballots)
  - Last day for BOE to receive mailed absentee ballots is the 10<sup>th</sup> day after the election due to recent updates in the election code
  - Proposed rulemaking would place BOE regulations in conformance with new legislation
- Final Rulemaking Amend Title 3 DCMR Chapters 10 and 11 (Removal of prohibition against registered voters who are eligible to sign a particular initiative, referendum, or recall petition being signatories on petition sheets that they circulate)
  - This is final rulemaking via the emergency & proposed rulemaking that was published in the DC Registrar on May 15.
  - No comments were received, and no substantive changes were made.
- **BOARD ACTION**: The Board unanimously approved the emergency and proposed rulemaking for publication in the June 26 DC Register, and final rulemaking for publication in the DC Register on same date.

# • Litigation Status

## o William v. Hunt. D.C. Board of Elections

- This matter was filed in US District Court on October 18, 2018 and is a complaint regarding the counting of write-in votes cast in the November 6, 2018 General Election.
- The Board filed a Motion to Dismiss on Wednesday, April 24, 2019
- The court granted the Board's Motion to Dismiss on March 10.
- Mr. Hunt appealed on April 22
- The Board is awaiting a scheduling order from the Court of Appeals

#### o Graham v. D.C. Board of Elections

- This matter involves the Board's appeal of a permanent injunction that was entered by the D.C. Superior Court on December 12, 2018 prohibiting the Board from taking any action on the Referendum 8 petition.
- All pleadings in this matter have been filed and a date for oral argument had been set for April 21. However, due to the public health emergency, all oral arguments in the DC Court of Appeals have been either cancelled or postponed.
- The Court will decide this matter without oral argument on the pleadings.

#### o Hammond v. D.C. Board of Elections

- This is an appeal of Board Order 19-32, upholding the resolution issued by ANC 7B which found no vacancy in the office of Advisory Neighborhood Commissioner for ANC SMD 7B04.
- On September 6, 2019, the Court of Appeals consolidated this case with *Robin Marlin v. the D.C. Board of Elections* (see below).
- On October 9, 2019, the Court issued a briefing schedule ordering the Appellants to file the appendix and their brief on November 18, 2019, and the Board to file its response on December 18, 2019 in both of these matters. The Appellants filed their briefs on December 16, 2019 and their appendix on March 4.
- We are waiting for the court to decide the merits of this matter on the pleadings.

#### Robin Marlin v. the D.C. Board of Elections

This is an appeal of Board Order 19-33, upholding the resolution issued by ANC 7B which found no vacancy in the office of Advisory Neighborhood Commissioner for ANC SMD 7B05.

# o Robinson v. the D.C. Board of Elections (DC Superior Court)

- Complaint for declarative relief filed on May 18 alleging that the Board's placement of three Ward 8 vote centers and its alleged failure to conduct targeted outreach for Ward 8 residents constituted a violation of section 2 of the Voting Rights Act.
- On May 21, the BOE filed a motion for summary judgement and motion to dismiss for lack of jurisdiction on the grounds that Voting Rights Act violations are within the jurisdiction of the US District Court for DC.
- On May 22, the court granted BOE motion to dismiss.

## Robinson v. the D.C. Board of Elections (U.S. District Court)

- Plaintiff filed a complaint and motion for preliminary injunction on May 21.
- Plaintiffs filed motion for temporary restraining order, which was denied on May 28.
- On June 10, BOE filed answer to original complaint.
- We are currently awaiting further scheduling instructions from Court.

  - The General Counsel responded that the notice was posted on the Board's website on June 13.
