SIGNATURE REQUIREMENTS FOR THE JUNE 16, 2026 PRIMARY ELECTION

Pursuant to D.C. Official Code § 1- 1001.08 (i)(3)-(4), the signature requirements for candidates to appear on the ballot in the June 16, 2026 Democratic, Republican, and D.C. Statehood Green Primaries are listed below, by party and office. Signatures gathered must be those of voters who are registered in the candidate's party on the date of signing the petition. For the ward offices, petition signers must also be duly registered to vote in the same ward from which the candidate seeks nomination. For any applicable local contests (Mayor, Chair or Member of the Council, Attorney General, Member of the State Board of Education, Advisory Neighborhood Commissioners, or ballot measures), petition signers can also include duly registered voters who are local residents/non-US citizens.
