# MINUTES OF THE BOARD OF ELECTIONS REGULAR MEETING January 8, 2020

The District of Columbia Board of Elections (the Board) held its Regular Monthly Meeting on Wednesday, January 8, 2020 in the Board's Hearing Room, located in Suite 750, 1015 Half Street, SE, Washington, D.C. 20003. Board Chairman Michael Bennett and Board Member Michael Gill were present. Also present on the dais were the Board's Executive Director, Alice Miller, the Board's General Counsel, Terri D. Stroud, and the Director of the Office of Campaign Finance (OCF), Cecily Collier-Montgomery.

  - Opinion Number 2019-04—Requested by Jordan Grossman. The issue concerns campaign expenditures related to attendance at local events. This matter is still pending.

# EXECUTIVE DIRECTOR'S DECEMBER 2019 REPORT (EXECUTIVE DIRECTOR MILLER)

# • Certification of Ward 2 Council Member Vacancy

- o Received notice on January 7, 2020 from Councilmember Jack Evans indicating his intent to resign his position effective 1/17/2020.
  - The Board must conduct a vacancy election within 174 days of the resignation, and the Board has scheduled the contest for June 16, 2020.
  - Director Miller presented a timeline of events:
    - ➤ 1/7 Board received notice of resignation
    - ➤ 1/8 Board will certify the vacancy during today's Board meeting
    - ➤ 6/16 The Board will conduct the special election
    - > FEP & OCF registration cycle for candidates begins today
    - ➤ 1/15 The Board will make nominating petitions available for candidates
    - ➤ 3/18 The deadline to file nominating petitions with the Board
    - > 3/21-3/30 The nominating petition challenge period
    - ➤ 4/10 Mandatory filing due for FEP-registered candidates
      - o For those seeking to register in FEP, the threshold requirements are at least 150 qualified small dollar contributions from residents of the District which in the aggregate total \$5,000.00 or more with an individual contribution limit of \$50.00.
  - BOARD ACTION: The Board voted unanimously to certify the vacancy for Ward 2 Council member, and to set the date for the vacancy election for June 16, 2020.

# • Polling Place Relocations (Mr. Arlin Budoo)

- Final Approval
  - Precinct No. 105, Benning Park Recreation Center, will be unavailable for the upcoming 2020 presidential primary election due to extensive renovations. We propose relocating to St. John's Baptist Church located at 5228 Call Place S.E.
    - ➤ **BOARD ACTION:** The final relocation of precinct 105 was approved unanimously, and notice will be published in the D.C. Register. This approval is conditioned on a verification of ADA

accessibility by Ms. Terrica Jennings, the Board's ADA Coordinator.

• On December 3, 2019, the Council formally adopted and established a new voting precinct in the District of Columbia that shall be designated as Precinct 144.

### • Voter Education and Outreach Division (VEOD)

o In the month of December, VEOD staff participated in 9 outreach events listed on the Board's website.

### • June 2, 2020 Primary Election

- o 1/10 Nominating Petitions available
- o 3/4 Deadline for submission of petitions
- o There is no indication from DCPS regarding school closures for the Primary Election.

### **BOE OGC DECEMBER 2019 REPORT (GENERAL COUNSEL STROUD)**

• Ms. Stroud introduced the OGC's new paralegal, Ms. Tonisha Erskine

### • Litigation Status

O William Hunt v. the D.C. Board of Elections. This matter was filed in US District Court on October 18, 2018 and is a complaint regarding the counting of write-in votes cast in the November 6, 2018 General Election. Mr. Hunt was a Mayoral write-in candidate in that election, and he filed a complaint asking the court to require the Board to count the write-in votes cast in the Mayoral contest.

Briefing in the case is complete and we are awaiting the court's order on the Board's motion to dismiss.

- O James Butler v. the D.C. Board of Elections. This is an action to compel the Board to accept the DC Term Limits Campaign Initiative and treat it as a proper subject. A conference for this matter took place on July 19. Dispositive crossmotions for summary judgment were due on November 21, 2019, at which time the Board filed its motion for summary judgment, but Mr. Butler did not.
- o **Graham v. the D.C. Board of Elections.** This matter involves the Board's appeal of a permanent injunction that was entered by the D.C. Superior Court on December 12, 2018 prohibiting the Board from taking any action on Referendum 8. Briefing in the case is complete, and the Court of Appeals has ordered the case be scheduled for oral argument as soon as the calendar permits.
- Order 19-32, upholding the resolution issued by ANC 7B which found no vacancy in the office of Advisory Neighborhood Commissioner for ANC SMD 7B04. On September 6th, the Court of Appeals consolidated this case with **Robin**

Marlin v. the D.C. Board of Elections (see below). On October 9, 2019, the Court issued a briefing schedule ordering the Appellants to file the appendix and their brief on November 18th, and the Board's response would be due on December 18th in both of these matters. The Appellants filed their briefs on December 16, but they did not file an appendix. On January 3, the Court ordered the petitioners to file an appendix within 15 days, and we await their filing.

o **Robin Marlin v. the D.C. Board of Elections.** This is an appeal of Board Order 19-33, upholding the resolution issued by ANC 7B which found no vacancy in the office of Advisory Neighborhood Commissioner for ANC SMD 7B05.
