D. Rulemaking to Title 3 of the D.C. Municipal Regulations (Elections and Ethics)

1. Final Rulemaking – Chapter 7 -- The purpose of the amendments to these regulations is to conform the Board's regulations to the Elections Modernization Amendment Act of 2022, provide for consistency between Board regulations, provide clarity regarding the commencement of the appeal period for Board decisions, adopt rules of conduct for attendees at Board meetings, and make other non-substantive housekeeping updates and corrections of typographical errors.
