#### **A. Rulemaking to Title 3 of the D. C. Municipal Regulations (Elections and Ethics)**

##### **1. Final Rulemaking**

- a. Chapter 5** - The purpose of the amendment to Subsection 504.7 of the regulations is to include tuition and housing statements from District of Columbia colleges and universities as valid and acceptable proof of residence. Some of these institutions print the student voter's residence address on the tuition or housing bill, while others include it on a separate statement. Including both bills and statements as acceptable proof of residence will ensure that all students can provide valid documentation and prevent disenfranchisement due to technicalities beyond the voter's control.
- b. Chapter 9** - The purpose of the amendments is to recognize the determination by the Council of the District of Columbia (see Sec. 9, Council Resolution 26-0017, approved February 4, 2025) that the Council's expulsion of a member results in a vacancy that triggers the procedures for filing vacancies and provide clarity regarding the date upon which vacancies occur.
