MEMORANDUM OPINION AND ORDER

This matter came before the Board of Elections and Ethics on Thursday, January 3, 2002, and involved a challenge to the candidacy of Bonnie Moss, candidate for the office of Advisory Neighborhood Commissioner ("ANC") in Single-Member District ("SMD") 4B02. The challenge was brought by Michael Sindram. The Board was represented by Chairman Benjamin F. Wilson and Member Stephen Callas. Both the Challenger and the Candidate appeared <u>pro se</u>.

According to the evidence presented to the Board, Candidate Moss submitted a nominating petition containing a total of 40 signatures. The minimum signature requirement to qualify for the ballot for this office is 25 signatures of persons who are duly registered voters in ANC-SMD 4B02.

Challenger Sindram filed a total of 40 challenges to signatures on the nominating petition. Challenger Sindram also filed a challenge to the candidate, alleging that she was not a registered voter in the District. As required by the Board's regulations, Challenger Sindram specified the alleged defects pursuant to 3 D.C.M.R. § 1309.2. Challenger Sindram alleged that Candidate Moss had failed to file the minimum 25 valid signatures of duly registered voters in ANC-SMD 4B02 for the following reason(s):

- 1) The signature was made by a person other than the person whose signature it purports to be (3 D.C.M.R. § 1307.2);
- 2) the signer is not a duly registered voter (3 D.C.M.R. § 1307.4(c));
- 3) the signature is not dated (3 D.C.M.R. § 1307.4(d));
- 4) the signature is not accompanied by the signer's printed or typed address (3 D.C.M.R. § 1307.4(f)),and;
- 5) the petition does not include the printed or typed name of the signer where the signature is not sufficiently legible for identification (3 D.C.M.R. § 1307.4(g)).

The review of the challenge conducted by the Registrar of Voters indicated that 5 of the challenges were found to be valid. This decreased the number of valid signatures obtained by Candidate Moss to 35 registered qualified electors, which exceeds the minimum number required for ballot access. The Registrar's review also revealed that Candidate Moss is, in fact, a registered voter in the District.

Thus, the challenge fails to provide an adequate legal basis upon which to reduce the number of valid signatures obtained by Candidate Moss below the legal minimum requirement.

Accordingly, the candidate retains enough signatures to remain eligible for ballot access.

In view of the evidence presented, the Board finds that the challenge is insufficient to remove the candidate's name from the ballot. Therefore, the Board denies the challenge as specified herein and in accordance with the report of the Registrar of Voters. Accordingly, it is hereby,

During the course of the hearing, the Board found an additional signature to be invalid, and thus further decreased the number of valid signatures obtained by Candidate Moss to 34 registered qualified electors, which exceeds the minimum number required for ballot access.

ORDERED, that Ms. Moss be granted access to the ballot in the forthcoming election to fill the vacancy in ANC-SMD 4B02.
