MEMORANDUM OPINION AND ORDER

Introduction

Wednesday, July 11, 2007 pursuant to D.C. CODE § 1-1001.05(a) (14) and 3 DCMR §

This matter came before the Board of Elections and Ethics ("the Board") on

1605, and involves an application for the approval of the name "One Minute Past Twelve Party" as a registered political party in the District of Columbia. The Chairman of the proposed party, Mr. He'lchie Watts, represented the political party before the Board. Chairman Charles R. Lowery, Jr. and Board member Dr. Lenora Cole presided over the hearing.

Statement of the Facts

Pursuant to 3 DCMR § 1605.3, Mr. Watts filed an application for the approval of

the party name on June 14, 2007. The proposed designated name of the new party is "One Minute Past Twelve Party." On June 25, 2007, Mr. Watts filed a Statement of Organization with the Director of Campaign Finance, pursuant to D.C. CODE § 1-

1102.04(a). During the hearing, the Board requested Mr. Watts to investigate and

determine if the designated treasurer is a registered voter of the District of Columbia. Since a voter registration number of the proposed treasurer could not be provided, as required by 3 DCMR § 1605.3², the Board concluded that the designated treasurer is not a registered voter of the District of Columbia. The Board consequently, accorded Mr. Watts leave to register the party's currently designated treasurer as a qualified District of Columbia voter, or in the alternative, designate a registered District of Columbia voter as the new treasurer of the proposed party.

On Friday July 13, 2007 Mr. Watts designated Ms. Jessica Cruz as the new treasurer of the proposed "One Minute Past Twelve Party". Ms. Cruz submitted her voter registration application, to the Registrar of the District of Columbia's Board of Elections and Ethics who subsequently issued her a preliminary voter registration number.

Analysis

In the District of Columbia, pursuant to D.C. Code § 1-1102.04(a) and 3 DCMR §§ 1605.2³ and 1605.3, each proposed political party must comply with established procedural requirements for approval of its name. The Board finds that all of the procedural requirements were fulfilled. The proposed party then submitted a revised application which contained the requisite information on the prescribed form. Finally,

The Board finds that the designated name. "One Minute Past Twelve Party" is sufficiently distinguishable from every political party in the District of Columbia and does not tend to lead or cause confusion or mislead the public. Accordingly, the Board

approves the name "One Minute Past Twelve Party" pursuant to D.C. CODE § 1-
