3	MR. BENNETT: Okay, I'm going to go
4	ahead and get started and we will move through
5	the items. Hopefully, we'll be able to get
6	Michael Gill on the line soon to have a quorum.
7	So let me just start off, I won't be
8	able to adopt any agenda and the minutes, until
9	Mr. Gill is on the line so we have a quorum to do
10	so.
11	Let me just kind of go straight to
12	board matters.
13	Can you hear us okay, reporter? Thank
14	you.
15	So let me just go straight to board
16	matters and at the top of the list and agenda is
17	the order announced, although it's been
18	publicized earlier, announced the appointment of
19	Ms. Terri Stroud as our new general counsel.
20	Welcome to her. And happy birthday for the
21	record.
22	MS. STROUD: Thank you. Thank you.

1 MR. BENNETT: Also, too, I'd like to 2 welcome to the podium here Ms. Monica Evans who is acting on behalf of Ms. Alice Miller who is on 3 4 vacation today and her birthday was a couple of 5 days ago. So thank you, Monica, for taking some 6 of your birthday time to be here with us today for this meeting. 7 8 I'm going to go ahead and move on to 9 a couple of other board matters before Mr. Gill is actually to join us --10 Michael, Michael, I'm on. 11 MR. GILL: 12 MR. BENNETT: Oh, you're on. Okay, 13 great. Excellent. 14 Well, let me go back. I won't go back and repeat what I've already done, but I'd like 15 16 to get an adoption of the agenda for today and 17 Mr. Gill, let me ask you --18 MR. GILL: I move to adopt the agenda. 19 MR. BENNETT: Okay. So that's 20 obviously seconded and it's unanimous. 21 And also the adoption of the minutes 22 from our last meeting, our June meeting, that was

1	actually held on May 29.
2	MR. GILL: I move to adopt the minutes
3	of May 29th.
4	MR. BENNETT: That's properly moved
5	and I second, so it's unanimous.
6	One other board matter is Ms. Dionna
7	Lewis had to submit her resignation from the
8	board just the other day. Today is Tuesday. I
9	guess it was on Friday or maybe even yesterday.
10	She's been nominated for another board in the
11	District. I can't remember the exact name, but
12	it's basically the labor appeals board for the
13	District and prior to she was nominated and had a
14	committee review and she was she passed the
15	committee vote and so now she's waiting for the
16	full Council's vote on her nomination for that
17	board. So as a result of that, she was required
18	to resign from this board.
19	And if you didn't know, there is
20	another person that is being is appearing
21	today at 1 o'clock for Ms. Karen Greenfield who
22	was nominated by the Mayor to take Ms. Wilson's

1 place on this board. And we hope that that 2 process goes through and that we are able to have a full complement of board members. But until 3 then, Mr. Gill and I are your board members and 4 5 we will serve diligently to get through any of the matters of the Board of Elections. 6 7 So with regard to the other board 8 matters, Mr. Gill, do you have any other board 9 matters? No, just that I would like 10 MR. GILL: 11 to remark that our loss will be the labor board's 12 gain. And it was a real pleasure to have served with Dionna. 13 14 MR. BENNETT: I echo that as well. 15 I'm not sure if you were on the line when I noted that Ms. Terri Stroud has been selected and 16 17 appointed as the general counsel of the board as 18 well. And today is her birthday. MR. GILL: Well, ah. Yesterday was my 19 20 birthday, Terri, so Cancers, lovely. 21 MS. STROUD: Cancers are wonderful. (Laughter.) 22

MR. BENNETT: Happy birthday to you,
too, Mike. I didn't know that. And if you
didn't know, Monica Evans is acting on Alice
Miller's behalf today.
MR. GILL: Yes, I knew that.
MR. BENNETT: Okay, great. All right,
so next on the board matters and we'll going
forward what we'll do is we'll make a statement
relative to any hearings or matters that we've
had to decide on as a board under board matters
for the previous month.
The two items that we had here last
month and that we actually had a special meeting
on matters associated with challenges of the ANC
seats that are currently occupied by Ms. Smith-
McDermott and also Mr. Johnson.
And I'll just read you the
administrative orders that were issued, at least
summaries of them.
In Hammond v. Smith-McDermott involved
an appeal brought by Philip Hammond from a
resolution issued by an Advisory Neighborhood

Commission 7B that found no vacancy existed in 1 2 the Office of the Advisory Neighborhood Commissioners for Single Member District 7B04. 3 The board determined that challenger Hammond did 4 not meet the burden of proving that Commissioner 5 Nicole Smith-McDermott did not meet residency 6 7 qualifications necessary to serve as ANC 8 Commissioner for SMD 7B04. Accordingly, the 9 board ruled that the resolution was valid. And i.e., Ms. Smith-McDermott would remain in her 10 position as the ANC Commissioner for SMD 7B04. 11 12 Let me just note that the decision of 13 the board was unanimous. The vote was unanimous. 14 And likewise, Marlin v. Johnson involved an appeal brought by Robert Marlin from 15 16 a resolution issued by Advisory Neighborhood 17 Commission, ANC 7B, that found no vacancy adopted 18 in the Office of Advisory Neighborhood Commission 19 for Single Member District 7B05. The board 20 determined that challenger Marlin did not meet 21 the burden of proving that Commissioner Villareal Johnson did not meet the residency requirement 22

1 necessary to serve as ANC Commissioner of SMD 2 7B05. Accordingly, the board ruled that the 3 resolution was not valid and Mr. Johnson remains 4 5 in that particular seat. And again, the vote by the board was unanimous. 6 7 Those two orders were issued on June 8 21st and posted on the board's website in the administrative order section. 9 And Hammond v. Smith-McDermott is 10 11 Order No. 19-032 and Marlin v. Johnson is Order 12 No. 19-033. So those are the board matters for 13 14 today. 15 And I'll ask Mr. Gill, do you have any 16 comments or any additional board matters? 17 MR. GILL: No comments and no 18 additional matters. 19 Okay, great. Thank you. MR. BENNETT: 20 Next item on the agenda is the Office 21 of Campaign Finance report. 22 Ms. Montgomery?

1	MS. COLLIER-MONTGOMERY: Yes, good
2	morning.
3	MR. BENNETT: I'm sorry, I forgot to
4	introduce those here. Ms. Cecily Montgomery,
5	Director of Office of Campaign Finance.
6	MS. COLLIER-MONTGOMERY: Good morning.
7	The first thing I would like to report is that
8	during the month of June, the Office of Campaign
9	Finance partnered with the Board of Elections in
10	its voter registration drive to conduct outreach
11	in the community and we visited three sites and
12	our supervisory training officer, Deloris Ramsey,
13	accompanied the board to these sites. And
14	basically the purpose was to provide information
15	on the Office of Campaign Finance as well as on
16	the new Fair Elections Program.
17	On Saturday, June 15, 2019, we
18	participated in outreach at the Mayor's Office on
19	Asian and Pacific Islanders Festival; on
20	Wednesday, June 19, 2019, the Metropolitan Police
21	Department Beat the Streets kickoff event at MPD
22	1st District in Ward 6, 201 M Street, Southwest,

in the Greenleaf Housing Community.

2 On Wednesday, June 26, 2019, at the Metropolitan Police Department Beat the Streets 3 event was held in the 7th District in Ward 8 at 4 1300 Congress Street, Southeast, in Congress 5 Heights. 6 7 In the Fair Elections Program during 8 the month of June, there were four new candidates 9 which registered to participate in the program. The first was John J. Fanning for Ward 2, City 10 Council on June 3, 2019; Daniel Hernandez for 11 12 Ward 2, City Council on June 4, 2019; Kishan Putta for Ward 2, City Council on June 26, 2019; 13

14 and Anthony Lamount Dale for D.C. At-Large City Council on June 28, 2019. 15

16 Also, the Fair Elections Program also 17 conducted outreach in the community. The FEP 18 staff visited the following ANCs: on June 5th, 19 1C; June 6th, 1B; June 12th, 6B02; June 24th, 4B; 20 and June 26th, 5B.

21 We also during the month of June in 22 the FEP Program met with our vendor on June 19th

to view the interim FEP e-filing system and I'm 1 2 happy to say that we're still on target and that we will be ready for the July 31st filing date 3 and which will be the first filing date for FEP 4 5 candidates. And what we intend to do prior to that date is to invite the candidates in so that 6 we can explain the use of the system to them. 7 8 In our Public Information and Records 9 Management Division, during the month of June,

10 there were no financial reports during June 29, 11 2019 for principal campaign committees or 12 political action committees or independent 13 expenditure committees or our constituent 14 services and statehood fund programs.

We did, however, have new candidates 15 16 and committees to register and they are as 17 follows: John Fanning, John Fanning for Ward 2 18 City Council again in the FEP Program, June 3, 19 2019; Daniel Hernandez, Daniel Hernandez for Ward 20 2 City Council in the FEP Program on June 4th; 21 Barbara Summers, Candidate for Mayor 2022, June 25, 2019; Veda Rasheed, D.C. Council Ward 7 22

Exploratory Committee on June 25, 2019; Kishan 1 2 Putta, Kishan for D.C. 2020, Ward 2 City Council again in the FEP Program on June 26th; Anthony L. 3 Dale, Dale for D.C. At-large City Counsel in the 4 FEP Program, June 28th; Save our Votes DC, that 5 is a political action committee that registered 6 7 on June 28th; Save Our Votes DC Independent 8 Expenditure Committee registered on June 28, 9 2019.

We conducted interim conferences 10 during the month of June. On June 10, 2019, the 11 12 participants were James Jennings, candidate, Vote 13 Jennings, Ward 7, DC Council 2020; Robin Salas, 14 Treasurer, Vote Jennings, Ward 7 D.C. Counsel 15 2020; Eleanor Ory, Treasurer, Committee to Hold 16 Jack Evans Accountable and Recall Jack Evans Now; 17 Robert Diener, Treasurer, Jan Spanning for Ward 18 2, and Ward 2 Citizens Recall; John Fanning, 19 Candidate, John Fanning for Ward 2; Jordan 20 Grossman, Candidate, Jordan Grossman for Ward 2; 21 Jonah Perlin, Treasurer; Jordan Grossman for Ward 2; Daniel Hernandez, Candidate, Daniel Hernandez 22

for Ward 2; Brandon T. Todd, Candidate, Re-Elect
 Brandon Todd 2020; Adam Hunter, Treasurer, Re Elect Brandon Todd 2020.

In our Audit Branch during the month 4 5 of June, the Audit Branch conducted seven desk reviews of principal campaign committees and 6 that, of course, includes the Mayor's reports. 7 8 We have four on-going full field audits. The first one is Sheika Reid for Ward 1 which was 9 initiated on August 29, 2018. 10 That is her principal campaign committee. 11 DC Proud 2019 12 Inaugural Committee, that was initiated on April 22, 2019 and that is an Inaugural Committee. 13 14 Committee to Elect Zachary Parker 2018. That was initiated on March 5, 2019. That is a newly-15 elected official 2/4/2018 election. Emily for 16 17 Education, initiated March 4, 2019, newly elected 18 official, school board 2018 election.

19There are no periodic random audits20which are ongoing. We issued two audits during21the month of June and these are compliance22audits. The first was Frazier O'Leary for Ward

That was issued on June 7, 2019. Again that 1 4. 2 is a newly elected official, school board official, school board 2018 election. And the 3 second was the Ward 4 Constituent Service Fund 4 5 and that was issued on June 4, 2019 and that is a Constituent Service Program. Both of the audits 6 are available on our website for view by members 7 8 of the public and I'll ask the general counsel, 9 Bill Sandford, to come forward and give the report of the Legal Division of the Office of 10 11 Campaign Finance. 12 MR. SANDFORD: Thank you. Good 13 morning, Mr. Chairman and distinguished Board 14 Member Gill. My name is William Sandford, 15 general counsel for the Office of Campaign 16 Finance. 17 During the month of June 2019, the 18 Office of General Counsel did not receive any 19 referrals as they were not required to file them, 20 however, we did complete 20 informal hearings and 21 issued 20 orders which included the following: ten orders for failure to timely file ANC summary 22

1	financial statements in which no fines were
2	imposed. Two failures to timely file orders
3	regarding Political Action Committees no fines
4	were imposed or issued. One failure to timely
5	file order regarding a principal campaign
6	committee in which no fines were imposed. And
7	seven failure to timely file orders in which
8	\$20,550 in fines were imposed or issued.
9	During the month of June 2019, the
10	Office of the General Counsel filed fines against
11	the following respondents. A fine of \$1,650 was
12	imposed against the Critical Campaign Committee
13	of Carley for Ward 5. A fine of \$3,150 was
14	imposed against Kenyan McDuffie, 2018 for \$4,000.
15	A fine of \$4,000 was imposed against Reid for
16	Ward 1. A fine of \$4,000 was imposed against DC
17	Recovery Act. A fine of \$3,350 was imposed
18	against DC Bike Life Compound. And a fine of
19	\$1,300 was imposed against DC Choice IEC.
20	During the month of June 2019, there
21	were no requests for interpretive opinions.
22	The Office of the General Counsel did

1 not carry or open any new investigations, and the 2 Office of the General Counsel did not conduct any show cause proceedings. And that concludes my 3 4 report. 5 Thank you, Mr. Sandford. MR. BENNETT: 6 Ms. Montgomery? 7 MS. COLLIER-MONTGOMERY: Yes, that 8 concludes the report of the Office of Campaign 9 Finance. 10 Mr. Gill, do you have any questions? 11 MR. GILL: No questions. Thank you. 12 MR. BENNETT: Thanks for your report. Next we'll have Ms. Monica Evans give her report 13 from the Board of Elections and in lieu of Ms. 14 15 Miller. 16 Ms. Evans. 17 MS. EVANS: Good morning. As 18 indicated, I am Monica Evans, the Special 19 Assistant to the Executive Director and I will be 20 giving Ms. Miller's report in her absence. 21 Canvass. The process is still on-22 going and it usually takes about eight months to

Essentially 218,000 voters were 1 complete. 2 canvassed and we're in the process of beginning to send forwardable cards to approximately 17,600 3 registered who had mailers identified as 4 5 undeliverable. The voters will remain on the voter role at the address listed in the board's 6 7 records through two additional federal elections 8 as required by law.

Additionally, 181,000 voters provided
no response to a canvass and by law no action is
required on those voters.

12 Continuing poll worker training. We 13 just completed the first round of poll worker 14 refresher training with the captains and special ballot clerks. Training began on May 22nd and 15 16 wrapped up on June 27th. We held nine captain 17 sessions and 14 special ballot sessions. A total 18 of 251 individuals participated in those 19 refresher trainings. The purpose was essentially 20 to increase the quality and to address concerns 21 and discrepancies that were identified during 22 this 2018 election cycle. The captains and

special ballot clerks were extremely appreciative of these additional trainings and we will be having the second round of trainings beginning this August.

5 Testimony. The board submitted testimony before the Council of the District of 6 7 Columbia Committee on the Judiciary on Public 8 Three pieces of legislation were Safety. 9 introduced for the purpose of increasing voter registration and turnout. The first piece of 10 11 proposed legislation provides employees with up 12 to two hours of paid leave in order to vote in District elections. And this would essentially 13 14 would have no effect on our operations. The second piece of proposed 15

legislation will require housing providers and title companies to give voter registration packets to new tenants and homeowners. And this will require the board to create a voter registration packet to provide to the Office of the Tenant Advocate and develop a packet that will be posted on our website. The bill also

requires the board to provide voting information
 on our website along with the search feature to
 elect individuals to identify their ward
 Councilmembers and Advisory Neighborhood
 Commissioner. And essentially these requirements
 can be accomplished and would be within the
 board's overall objectives.

8 The final piece of proposed 9 legislation requires the board to solicit opinion from the Attorney General for the District of 10 Columbia and its General Counsel of the Council 11 12 of the District of Columbia on whether the subject matter of an initiative or referendum is 13 14 a proper subject matter before the board accepts 15 the proposed measure. These measures are 16 consistent with the agency's mission and the 17 board does not have any objection to these 18 requirements. Additionally, initiative measures 19 would only appear on general election matters. That concludes the Executive 20 21 Director's report. 22 MR. BENNETT: Great. Any questions,

1	Mr. Gill?
2	MR. GILL: No questions. Thank you.
3	MR. BENNETT: Okay. Next is the
4	report of the General Counsel.
5	Ms. Stroud:
6	MS. STROUD: Good morning. The first
7	item on my agenda is the litigation status. The
8	first case is William Hunt versus the D.C. Board
9	of Elections. This matter was filed in the
10	United States District Court for D.C. on October
11	18, 2018 and it's a complaint regarding the
12	counting of write-in votes cast in the November
13	6, 2018 general election in the mayoral contest.
14	Mr. Hunt filed a complaint prior to
15	the general election because he wanted the board
16	to count the write-in votes cast in that contest.
17	Because the number of write-in votes cast in the
18	mayoral contest was not sufficient to elect a
19	write-in candidate, the board was not required to
20	count the write-in votes. Rather, the board
21	reported those number of write-in votes cast in
22	the aggregate and provided that number in the

certified election results which are posted on
 the board's website.

While the complaint was filed on 3 4 October 18, 2018, the board was not made aware of 5 the complaint until April 15th of this year due to filing and service errors on the plaintiff's 6 7 part and the board was not formally served until April 26, 2019. The board filed a motion to 8 9 dismiss on Wednesday, April 24th and we are awaiting the court's decision in this matter. 10 11 The second case is James Butler versus 12 the D.C. Board of Elections. Mr. Butler filed this action in the Superior Court seeking a writ 13 14 of mandamus to compel the board to accept the D.C. term limits campaign initiative as a proper 15 16 subject. The initial scheduling conference for 17 this matter will be held on July 19th. 18 The final matter involves the board's 19 appeal of a permanent injunction entered by the 20 Superior Court on December 12, 2018 which 21 prohibited the board from taking any action on the referendum 008 petition. The permanent 22

injunction was entered on the basis that the board had failed to provide adequate public notice of the meeting at which the board formulated the referendum short title and summary statement.

6 The proposer of the referendum is also 7 appealing the preliminary injunction and that 8 appeal was consolidated with the board's appeal. 9 The board and the proposer filed a joint brief 10 and appendix on June 26th and the appellee's 11 brief is due on July 26th.

12 And I have another matter concerning 13 final rulemakings that the board acted on during 14 the May 29th hearing. These amendments concern 15 Chapter 5. One supported the Voters 16 Confidentiality Act and the other listed the 17 District's voter registration agencies.

And the final rulemaking concerned the Office of Campaign Finance Operations. While the regulations were sent to the D.C. Register on May 21 29th after the board's meeting, they were not accompanied by the final rulemaking transmittal

1 forms, so they have been sent and will be 2 published in next week's D.C. Register. And that concludes my report. 3 4 MR. BENNETT: Great. Any comments, 5 Mr. Gill? 6 MR. GILL: No comments. Thank you. 7 MR. BENNETT: Okay. Now we're going 8 to move over to public matters and what I'd like to do is to reverse a little bit and I'll take 9 10 public matters from persons that are physically 11 here today first, and then persons over the 12 phone. 13 Ms. Brazil. 14 Good morning. My name is MS. BRAZIL: 15 Dorothy Brazil. I'm the Executive Director of DC 16 Watch. Our mailing address is 1327 Gerard 17 Street, Northwest. 18 I have a couple of questions I wanted to direct to the board and a request for some 19 information. 20 21 The first one is easy. Ms. Monica 22 Evans indicated at the June 13th meeting of the

Council to consider pending legislation that 1 2 would affect voter turnover, the Board of Elections gave testimony. I was at that hearing. 3 No testimony was delivered by the Board of 4 5 Elections. If there is such testimony, I'd like to get a written copy of it. 6 MS. EVANS: Yes, we did not provide 7 8 in-person testimony. That was in writing. 9 MS. BRAZIL: Not only that, but no one showed from the board. 10 11 The next thing I would like to ask is 12 what are the rules of the board --13 MR. BENNETT: And the board would just 14 like to make sure we're clear. We'll be happy to 15 send you that testimony. That testimony wasn't 16 posted or anything on the website. Are you familiar with that? 17 18 MS. EVANS: I know we have the 19 testimony. I'm not sure whether or not it was 20 posted -- it was not posted on the website. 21 MR. BENNETT: We'll be happy to 22 forward it to you.

1	MS. EVANS: Yes.
2	MS. BRAZIL: If the chairman could
3	enlighten me as regards, what are the rules
4	regarding board members participating on the
5	telephone? I know that at one point the adoption
6	of a rule that indicates that at your discretion
7	you can allow a board member to participate by
8	video conference, telephone conference, or by
9	other means of communication. But I also recall
10	you gave some explanation that you did not
11	believe that at any time it would affect more
12	than one member of the board. You're down one
13	member because of Ms. Lewis' resignation and now
14	you have Mr. Gill on the phone. And the same
15	thing occurred at last month's meeting when you
16	actually had two people on the phone who were
17	board members.
18	Can you tell me what the or could
19	the general counsel tell me what the existing law
20	and regulation is regarding board members
21	participating in board meetings and not being
22	physically here? And can you give me the

citation. 1 2 MS. COLLIER-MONTGOMERY: Sure. One 3 moment. 4 (Pause.) MR. BENNETT: While she's looking it 5 up, is there another question coming, Ms. Brazil? 6 MS. BRAZIL: 7 Yes. I had another 8 question as regards board's processes. Ι understand that the Board of Elections is an 9 independent agency of the District government and 10 11 that it believes it has independent authority 12 regarding personnel in contracting matters. 13 Can you give me the citations to a 14 position and the code and the regulations? And 15 can you provide me with a copy of any personnel 16 rules and regulations or any contracting rules 17 and regulations that you believe to govern the 18 Board of Elections? 19 MR. BENNETT: I'd be happy to. Ι 20 don't have one at my fingertips. I'd be happy to 21 provide those to you after the meeting. 22 MS. BRAZIL: After the meeting?

1	MR. BENNETT: Yes.
2	MS. STROUD: And Ms. Brazil, with
3	respect to your question regarding the regulation
4	regarding board members participating in board
5	meetings other than in person, 3 DCMR 102.3
6	provides that except as provided otherwise by
7	statute, a quorum of the board shall consist of
8	no fewer than two members of the board and shall
9	be necessary to conduct official board business.
10	At the discretion of the chairperson, any member
11	may participate in a meeting of the board by
12	means of a videoconference, telephone conference,
13	or by any means of communication by which all
14	persons participating in the meeting are able to
15	hear one another and such participation shall
16	constitute present, in person, at the meeting.
17	MS. BRAZIL: And you cited 3 DCMR 103
18	or 102?
19	MS. STROUD: 102.3.
20	MS. BRAZIL: 102.3?

2	MR. BENNETT: And Ms. Stroud, will you
3	provide Ms. Brazil with the citation for
4	personnel matters after the meeting?
5	MS. STROUD: Sure.
6	MS. BRAZIL: And my final matter
7	concerns the website. After repeated statements
8	by me at your board meeting as regards problems
9	with the website and not being able to search it
10	for cases or other matters, has there been any
11	effort to improve the website in terms of
12	information that's posted on it?
13	MR. BENNETT: I don't have an answer.
14	I haven't focused on it myself.
15	MS. STROUD: We will check into that.
16	We have been making improvements, and we take
17	into account, as I am aware, some of the
18	suggestions that you have made particularly with
19	respect to administrative orders, but we are
20	still working on it with DataNet, our vendor.
21	MR. BENNETT: I know that Ms. Miller
22	focused on it after the last, but she's not here

I

1	today. And I will assume that Ms. Evans hasn't
2	consulted with her about that.
3	MS. EVANS: I have not.
4	MS. BRAZIL: Well, you know, Mr.
5	Chairman, the good thing about these meetings
6	meetings is the fact there is a court reporter
7	who records the meetings. I have been making
8	pleas, bringing to your attention the problems
9	with the website consistently for at least six
10	months.
11	So as we go into the 2020 elections,
12	I think that it more than behooves the board and
13	more than enough time has passed, especially
14	since all you're telling essentially is you're
15	passing it off to a vendor to do.
16	Can you answer me one question? Who
17	on the board staff, a physical body on the board
18	staff is responsible for submitting information
19	to be posted and/or monitoring the website? Is
20	there anybody?
21	MR. BENNETT: Yes. Our Public Affairs
22	

MS. STROUD: Our Public Affairs 1 2 Information Officer is Rachael Coll. I know that she's in regular contact with her and I know that 3 4 one of the concerns that you had on our website 5 concerning our administrative orders was the fact that there was not a sorting feature. 6 In the times that we've taken your concerns into 7 8 account, we have created a sorting feature for 9 orders. They can now be sorted by date, number, 10 or subject. 11 Okay. My final question MS. BRAZIL: 12 concerns the positions of different counsel. Can 13 you enlighten me as regards what the board's 14 process was for Mr. McGhie no longer being the general counsel and for Ms. Stroud being 15 16 appointed general counsel? 17 Can you give me some specifics as 18 regards how that process went down and why it was 19 conducted behind closed doors? Specifically, 20 where was the position posted for filling? 21 MR. BENNETT: The position was -- I'll 22 start at the back part of your question. The

position was never posted. The board has the
 authority to --

8 Good afternoon. MS. HAYES: I'm 9 Tamika Hayes of the Fair Elections Program. Ι processed in attending the ANC meeting to get a 10 11 confirmation from someone in charge of each 12 meeting from each ANC Commission and on that 13 specific day we did not receive a confirmation 14 that we were going to be placed on the agenda until it was between 4 p.m. and 5 p.m. which was 15 16 too short of a notice for our staff to adjust to 17 make sure that we could be in attendance. So you 18 need a confirmation from the ANC specifically for 19 us to rearrange our schedules.

We had sent the confirmation out prior to and on that specific day, it was just too much of a short notice to see who could actually

attend the meeting. So we reached out to them.
 We actually had Ms. Ramsey reach out and let them
 know that the notice was too short and if we
 could reschedule.
 MR. BENNETT: So it sounds like that

6 the ANC put somebody's name on that and really shouldn't have been there based on who they 7 8 contacted, Ms. Ramsey contacted. The manager of 9 the Fair Elections Program is Mr. Eric Jackson, 10 so that agenda you're looking at, Mr. Sindram, probably was sent out by the ANC and that was 11 12 just a mistake of they gave Ms. Ramsey the wrong 13 title.

14 MR. SINDRAM: It sounds right, it is just a bit misleading because the way it is 15 16 written on this agenda item it indicates Deloris K. Ramsey, Fair Elections Manager, is indeed 17 18 their elections manager when evidently not. It's 19 what, Mr. Eric Johnson? 20 Eric

20 MR. BENNETT: Mr. Eric Jackson. Eric 21 Jackson is actually the Fair Elections Manager. 22 MR. SINDRAM: Okay.

1	MR. BENNETT: It sounds like it was
2	just a misunderstanding at the ANC.
3	MR. SINDRAM: The explanation of short
4	notice between 4 and 5, the show time for the
5	meeting was 7 p.m. So you guys would have been
6	there anyway and I don't understand why the
7	failure to show up. It would be most helpful if
8	you guys were there to field questions from the
9	community and so on, but be that as it may, you
10	made mention rescheduled. Do you have a date and
11	time certain of coming, when you'll be at our ANC
12	4B meeting?
13	MS. HAYES: We do not have a date and
14	time scheduled at the moment, but we will
15	definitely be more than likely at the next board

20	MS. HAYES: I say more than likely we

2	MR. SINDRAM: For 4B, they'll not be
3	meeting July and August. The next meeting will
4	be September 23rd at 7 p.m., the same location of

6	Avenue, N.W. I look forward either meeting you
7	or Mr. Eric Jackson or Deloris Ramsey or someone
8	there that could enlighten us as to in more
9	depth, detail, what you guys do and that could
10	field questions from the community. It would be

12	MS. HAYES: Just to confirm, you said
13	September 7th at 6:30?

12	Jackson would like to add something else in
13	summary, just walk back in to that explanation.
14	I'd be happy to have it, but
15	MR. JACKSON: Sorry, Mr. Chairman,
16	what's the question again?
17	MR. BENNETT: The question was what is
18	the Fair Elections Program and I just gave him
19	the short answer. It's basically public funding
20	for people running for those offices that I
21	mentioned. And there's certain requirements that
22	you have to meet in order to receive public

1 funding, but it's a fairly lengthy explanation 2 that this meeting is probably not the proper place to provide that. 3 Mr. Sindram, does that answer your 4 question, Mr. Sindram? 5 I thank you for your 6 MR. SINDRAM: 7 explanation. If Mr. Jackson wanted to weigh in, 8 that would be a propos. 9 MR. JACKSON: Hi, how are you? Fair 10 Elections Program is a publicly-funded program 11 that allows the District of Columbia to provide 12 public funding for people running for elections. 13 It actually -- if you are opted into the program, 14 you must adhere to the program's requirements which require only smaller dollar contributions. 15 16 If you're running for say a ward race, which is 17 we have open ward race, multi-candidates to Ward 18 2, you can only have a contribution of \$50 or 19 And it has to be from individuals, no less. 20 corporate donations, no businesses or anything to 21 that nature. 22 MR. BENNETT: Is that helpful, Mr.

1	Sindram? I'm really hesitant to go a lot further
2	because there are a lot of requirements and we
3	could be talking about it for another hour.
4	MR. SINDRAM: I got you. Thanks. In
5	the interest of time, Mr. Chair, I appreciate it.
6	I look forward to making your acquaintance should
7	you be at that meeting, Mr. Jackson. Hopefully,
8	you and certainly someone from your office.
9	I did want to bring to your attention
10	and this may be a little out of your lane that
11	from ANC 4B09, La Roya Huff is the Commissioner
12	of that SMD. She works for Brandon Todd.
13	Actually, she's a constituent services person and
14	I think clearly that's a conflict of interest.
15	That may be something for the board overall or
16	another entity to look at, but I'm just putting
17	it out there that that clearly appears to be
18	conflict of interest and we've had Mr. Todd's
19	name surface on using his office for board
20	representative election, throwing the election,
21	if you will, and I think he was reprimanded,
22	fined, or whatever, which is not good.

1	One of the things, we want to open it
2	to all, and we also want to play by the same
3	rules. And just because you got some juice in
4	terms of being an incumbent, you've got a war
5	chest that's sizeable, that should not carry the
6	day.
7	What will carry the day is when you
8	have open elections, when you have fair and
9	equitable voting and opportunity for all, not
10	just because of name recognition, status,
11	stature, whatever, and I know, Mr. Chair, you
12	have said this repeatedly, you want to open up
13	the voting mechanism not only to we, the people,
14	but to any and all eligible who's heart desire is
15	to serve, or a true and pure motive to represent
16	we, the people. So I echo and support you in
17	that endeavor, the board's endeavor, and
18	hopefully with this now Fair Elections Program,
19	that will bolster that mindset and give greater
20	credence. Because right now the culture of
21	corruption is alive and well. As Phil Mendelson
22	said, the Chair of the Council, the integrity of

1	the Council is eroded, no, it's obliterated.
2	And one thing more, term limits, of
3	course, Jack Evans, I don't want to ask you, but
4	what's the status on your end with that. I know
5	under multiple investigations, but he continually
6	pushed no term limits. And we voted on that in
7	1992.
8	So again, Mr. Chair, on the one hand
9	if you are inviting and enlisting our support and
10	when we do come to vote and then later on, the
11	motley crew at the granite palace, the Wilson
12	Building, negates and nullifies what we, the
13	people have voted, why bother? Same thing with
14	Initiative 77, on that beat.
15	So term limits, number one. And
16	number two, outside employment. That has given,
17	and I think Ms. Montgomery, you can echo this
18	concern. When you've got outside employment,
19	right, that gives the pay to play greater the
20	fix is in, okay. And so for Mary Cheh of Ward 3,
21	teaching full time at G.W. Evans became a lawyer
22	full time and others. That's telling we, the

people, that's telling me the public trust is not 1 2 at the forefront. It's the outside gate. You don't need the outside 8 employment. That's for being greedy and not 9 needy.

MR. SINDRAM: We need an elephant in 10 the room, Mr. Gill. Where are you? 11 12 MR. GILL: Michael Gill, again, and I 13 have no questions. 14 MR. BENNETT: Any other public comments for public matters on the line? 15 16 MR. SINDRAM: And brief indulgence, 17 one question if I may for Mr. Gill. 18 Does the RNC, Republican Committee 19 party now have a set office in D.C.? They did at one time when Ron Moten ran and then it kind of 20 21 -- it went away, but do you guys now have a set office to take care of business, Republicans? 22

1	MR. GILL: So Michael, one of the
2	beautiful things about serving on the Board of
3	Elections is that I'm no longer affiliated with
4	them, and I'm prohibited from having any
5	political leanings and such. So I have no idea.
6	MR. SINDRAM: I'm not asking you a
7	question substantive. I'm asking procedurally,
8	does the Republican Committee have an office in
9	D.C., and if so what is the address and contact
10	information?
11	MR. BENNETT: He's just saying that he
12	doesn't know, Mr. Sindram.
13	MR. GILL: I don't know.
14	MR. SINDRAM: Thanks, Mr. Gill. And
15	next time we meet, I don't want the excuse the
16	dog ate my homework, the train had a flat tire.
17	MR. BENNETT: Any other public matters
18	on the line? I think Ms. Lewis was on the line.
19	Are you there, Ms. Lewis?
20	Unfortunately, she was not able to stay on and
21	join us.
22	Anyway, if there are no other public

matters, we may have an opportunity to celebrate with Ms. Lewis in person next month.

And Mr. Chair, in light 3 MR.
