## Early Vote Centers Open on October 31

**WASHINGTON, D.C.** – The District of Columbia Board of Elections (DCBOE) reminds voters that 25 Early Vote Centers will open on Monday, October 31, 2022.

Early Vote Centers will be open daily from 8:30 am to 7:00 pm through November 6. DCBOE will operate 90 Vote Centers on Election Day, November 8. Election Day Vote Centers include all Early Vote locations.
