20	percent turnout. We had 10,585 special absentee
21	ballots by mail. And 168 voters showed up in
22	person to vote.

1 So with that background, the person 2 receiving the highest number of votes, the candidate receiving the highest number of votes 3 4 was Brooke Pinto. And we would certify Brooke 5 Pinto as the winner of the June 16th special election to fill the vacancy in the Ward 2 6 7 council seat. 8 CHAIR BENNETT: Okay. Any questions, 9 Mr. Gill? MR.
